### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

<b>General information</b>	Change clothes and shoes contaminated or soaked by product. Never put rags contaminated by product into cloth-pockets. Get medical attention if any discomfort continues. Not expected to give rise to an acute hazard under normal conditions of use.
<b>Inhalation</b>	Remove affected person from source of contamination and immediately take outside to fresh air. Consult a doctor if any discomfort continues.

<b>Protective actions during firefighting</b>	In case of fire, shut off flow if it can be done without risk. Stop leak if safe to do so. In case of splashing or scattering, wear protective oil-resistant or chemical-resistant clothing.

##### Eye/face protection

##### Hand protection
